Paul Hamlyn Foundation – Act for Change Fund – Deadline: 1st April 2019

Not-for-profit organisations with an income of between £25,000 and £5 million working with young people between the ages of 14 and 25 years have until the 1st April to submit a stage one application. The fund provides resources to not-for-profit organisations supporting young people to challenge social injustice, find ways of overcoming inequality and give voice to the issues they are experiencing. Grants in the range of between **£20,000** and **£100,000** over two years are available. It is expected that a total of around 30 organisations will receive support through this programme. Larger grants will be considered on an exceptional basis.

Bruce Wake Charitable Trust

The Trustees will consider grant applications related to the provision of leisure activities for the disabled but favour particularly applications whereby the potential beneficiaries meet one or all of the following criteria:

- The potential beneficiaries are physically disabled wheelchair users
- Improved access for wheelchair users is proposed
- A sporting or leisure activity involving disabled wheelchair users is proposed

Persimmon Homes – Building Futures

Persimmon Homes has announced its £1 million Building Futures programme, which will assist community sports, education and arts and health initiatives for under 18s. A total of 128 grants of **£1,000** will be awarded.

Building Futures will involve giving even more this year. It is aimed solely at community projects for under 18s and targeted at:

- grassroots sports groups
- community groups dealing with physical and mental health issues and awareness
- arts and education projects.

Premier League & The FA Facilities Fund Small Grants Scheme

The Premier League and The FA Facilities Fund Small Grants Scheme awards grants of up to £10,000 for the provision of capital items, or to refurbish/improve existing facilities. The aims of this scheme are to:

- Support the growth of football clubs and activity.
- Prevent a decline in football participation.
- Make improvements to facilities to address any health and safety issues.

The maximum grant available from the Premier League and The FA Facilities Fund Small Grants Scheme is **£10,000**. The minimum grant is **£1,000**, unless you are applying for funding towards the replacement of unsafe goalposts.

The Edward Gostling Foundation

The Edward Gostling Foundation provide grants to other charities that are registered and regulated by the Charity Commission with the aim of enhancing the quality of life of people in need and, particularly, those on a low income who have a physical and/or mental disability or long-term illness. The four themes are:

- **Health & Wellbeing** - supporting access to community facilities to maintain, improve and enhance general welfare
- **Independent Living at Home** - helping people to live independently in their own home for as long as possible
- **Respite** - enabling carers to take a break from the responsibility of caring for a loved one
- **Transition** - supporting the journey through education and personal development programmes into employment, long-term volunteering or other meaningful daytime activity, housing and independent living
